Head of Cheer- Kristen Tavlor

- Cheer Comp-

## Old Business

- Banquet dates-
  - Via text message Jenn states Holly Academy can fit 220 people.
  - Kristen suggests doing cheer 3-4, with football to follow at 5:30-9. Starting with flag football.
  - Destiney suggests having flag will go at the same time with cheer, with Freshman and Jv tackle we are at about 60-80 players alone not counting families.
  - Suggest cheer and flag 3-4:30 and tackle to follow 5:30-9.
  - Janelle suggests having volunteer spots for banquet day as a way for parents to help.
  - \$25 per family, Destiney will send out a forum for parents to register.
  - Pasta from Red Devil, pizza from Little Caesars and make the salad and get desserts and rolls and water from Sam's CLub.
- Voting on combining Paret Agent and Player Agent Position-

- Voting on Head of Tackle, Cheer, & Flag positions -
  - Destiney Bailey makes motion to add the Head of Tackle, Head of Cheer, and Head of Flag position as executive board positions. Seconded by Audrey Bishop.

## New Business

## Public comment

- Dan Couchman wants to discuss cutting teams for next year. Mike states that this was something Trevor and he had gone back and forth on. The decision had to be made so with the numbers we had at the beginning of the season it seemed to be the right decision.
- Scott Blaska asks for next year can we look to increase the number at which we split? Mike states yes next year we can make that decision.
- Scott suggests making a wait list once we hit the cut off number for a team.
- Krsiten states that coaches will have to communicate with parents that without splitting teams your player may not see as much field time. Scott states that this is something that will need to be discussed but at that point we at least won't be putting kids in positions that could cause them harm. Mike states we need to just make sure coaches stick to rotating kids.
- Scott Blaska, Dan Sanderson, and Dan Couchman state that next year we should incorporate that head coaches attend the monthly board meetings. If they are unable they elect a team representative (being another coach). This way keeps all teams involved in what is happening throughout the year.
- Destiney thinks this is a great idea and would help with relaying information.
- Mike Bishop makes a motion for every head coach from Cheer, Flag and Tackle to become a Trustee Board member. Seconded by Janelle Rose. Motion passed unanimously.
