**Approval of Minutes**

Victoria Mingo-Williams moved to approve last months meeting minutes. Seconded by Christine Prekup. **Motion passed unanimously.**

**Approval of Agenda**

Briana Opalewski moved to approve the agenda for today's meeting. Seconded by Greg Kish. **Motion passed unanimously.**

**Board Reports**

President - Destiney Bailey

- Destiny states that the current registration numbers are 9 for flag 5/ 6, 18 for flag 7/ 8, 21 Freshman tackle, 25 JV tackle, 20 Intro to cheer, 17 Tackle Cheer, 6 JV cheer and 9 freshman cheer.
- Destiney states she sent an email to CD dismissing him from coaching because of harassing texts to 2 of our board members but said that his son could still play for the

program. He replied back stating our program was a joke and he wouldn't be playing. Destiney checked with Holly Jarvis to make sure we were following protocol and we invited him to be here tonight. He said he wouldn't be coming. Dan asked why we are allowing him to be around after the harassing texts. He states that we pay for the field and he shouldn't be allowed there when we're there. **Dan Couchman makes a motion that we put an expectation of a formal apology for his actions pending board approval. Seconded by Destiney Bailey. Motion passed unanimously.**

- Destiney states that we have 2 Freshman Cheer Coaches, 3 Intro to Cheer coaches, 1 JV Cheer Coach, 4 Freshman Tackles Coaches, 5 or 6 JV Tackle Coaches, 2 5 /6 Flag Coaches and 2 7 /8 Flag Coaches.
- Destiney asks if we want to extend registration for Flag Football since the jerseys are easy to get. We can extend until the 29th?

Vice President - Greg Kish

- Greg states he'd like to make a budget for first aid kits. Every coaches bag gets one. \$20 a kit- once we close registration we'll know what we have to get. The kits need to include disposable ice packs (100) and tape.
- Greg states we definitely need more mouth guards to keep on hand and game balls. Bishop gave us 4. Greg suggests looking into guardian caps for practice. It's \$70 per cap for the basic one. We can buy 3 per team and it'll be the coaches discretion on who to hand them out to... RB, QB etc. **Destiney Bailey makes a motion to spend up to \$1000 for equipment for the 2025 Season. Seconded by Christine Prekup. Motion passed unanimously.**
- Greg states we need to make sure coaches have a cleared background check on file. Once we establish coaches we need to set up concussion training and play counters.

Treasurer- Dan Couchman

- The current account balance is \$25,914.42
- Dan states that \$100 came out for Sam's Club but isn't our membership. He states that that was supposed to be canceled and we were going to get a program membership.
- Dan also states he talked to Ridelle this morning. The helmets are supposed to ship friday. If we don't get them we should have enough to start the season with. Dan states were good on shoulder pads. We bought some last year and the year before.

#### Fundraising Coordinator- Chrstine Prekup

- Christine states she wants to have a "Team Bonding" event August 9th at the 7 Lakes Pavillion but would need the money to book it. **Destiney Bailey makes a motion to spend the money on the pavilion. Seconded by Victoria Mingo-Williams. Motion passed unanimously.**
- Christine states she has copies of the sponsorship forms and they are good to go!
- Christine says she asked Big Poppas about dates for their fundraiser. They will give us 15% back on proceeds. She chose June 11, 18th and August 9th. All our camp dates so if parents don't feel like cooking they can order pizza.
- July 12th is the Springfield Inns Parents night out. 6-9 is live music and 9-2 is karaoke.
- Christine states she was looking at the Yeti Roadie for \$375. But that the Artic is \$279 and we could get a 2nd prize coolerbag with the extra money. **Destiney Bailey makes a motion to spend \$400 on cooler supplies. Seconded by Victoria Mingo-Williams. Motion passed unanimously.**
- Christine is getting the raffle tickets ready. Destiney will print them and have them ready for our camp in July.
- Christine suggests we open spiritwear early, reopen the staycation and reach out to the people from last year.
